I hereby apply for space at the Lemon Bay High School Manta Market. I understand I am renting the area within the marked outline of a parking space at Lemon Bay High School parking lot, located on 2201 Placida Road, Englewood, FL; 10:00 AM until 2:00 PM. I understand and agree to comply with the following conditions:

1. The Charlotte County School Board, its employees, agents or volunteers accept no responsibility whatsoever for any of the items brought to the facility for sales or marketing.
2. Vehicles are to be parked in the assigned parking spaces and not moved between 10am and 2pm.
3. No food or drink items are to be sold by vendors unless approved by LBHS.
4. All trash caused or created by vendor is to be removed by vendor.
5. The parking space is to be clear of all unsold items upon leaving the space.
6. Vendors are responsible for collecting and reporting sales tax, if it is required.
7. No refunds or transfers of money.
8. Vendors are to provide their own tables.
9. Vendors cannot sublet their space to others. Double space is for one vendor only.
10. Vendors must be set up by 9:45 and shall not break down until 2:00pm.
11. No refunds for no shows.
12. No make-up day if it rains. Prepaid vendors will be credited for the next market in the event of a rainout.

Manta Market Time: 10a.m.-2 p.m.

- Vendors can arrive at 8:30 a.m. - 9:45 a.m. to check in and set up. Space numbers will be emailed no later than 3 days before market and also given at check in.
- Vendors must have vehicles removed from the sale area as soon as they are unloaded.
- Vendors should unload, remove their vehicle and then return to set up. Do not leave your unloaded/unattended vehicle in the vending area. For the safety of patrons and other vendors, vehicles will not be permitted to return to the vending area until 2p
